

#### August 1997

#### **Hard Time**

From 1873 until 1878 the local calaboose was located at Rusk (Commerce) and Second, and consisted of two cells and a dungeon. The log structure had one barred opening for light and ventilation, had no plumbing or running water, and cost less than \$500 to construct. A standard joke in Fort Worth at the time was "What is the difference between the moon and jail? The moon is full once a month but the jail is full every night."

#### February 1999

## Origin of the Phrase "A White Horse Case"

"Around the turn of the century, a Texas law firm had a case in which a white horse owned by the client's taxi service reared in the street, causing an elderly woman to fall and injure herself. The partner handling the case asked a young associate to find a case on point. The associate came back several hours later with a case involving an elderly lady who had fallen in the street after a taxi company's black horse had reared in front of her. When the associate took this case to the partner, the partner said 'Nice try, son. Now, go find me a white horse case."" Hilland v. Arnold, 856 S.W.2d at 242, note 1, (Texarkana) [Thanks to Christian Jenkins for this item.].

#### April 2002

#### **Ordinance 92**

On December 26, 1876, the city council passed Ordinance 92 which prohibited males from "riding, walking or promenading" in public areas of the city with any "prostitute or woman of ill fame", subject to fines ranging from 10 to 25 dollars. The legal question of who in fact was a prostitute was to be determined by "general reputation" or by "prima facie evidence." Public outcry and the questionable legal standard led to an amendment in February of 1877, such that only "riding or driving" with such women between the hours of 4 a.m. and 9 p.m. was prohibited.

#### THE GREATEST

In 1920 Babe Ruth hit more home runs than fourteen of the sixteen big league TEAMS!

#### April 2007

A series of intricately carved faces graced each of the four porch capitals of the Ellis County Courthouse, ranging from the sublime to the grotesque. Legend has it that German itinerant stone carver Harry Herley fell in love with the local girl Mabel Frame, whose grandmother operated the boarding house where he resided while sculpting all the courthouse's exterior ornamentation. Herley loved Mabel Frame dearly, the myth proclaims, but she

did not return his love. The beautiful likenesses of Mabel portrayed on the stone porticoes soon turned into demons. Time and the dwindling love affair are portrayed as one walks around the courthouse.

#### January 2008

## LAW AND ORDER: ONE PHOTO IS TOO MANY

The well-known photograph of the Wild Bunch—Butch Cassidy, the Sundance Kid, Ben Kilpatrick, Will Carver, and Harvey Logan—in which they are dressed in coats, ties, and bowler hats, was taken in the fall of 1900 at Schwartz View Co., located at 705 Main Street. The photo led to the gang's break-up and eventual demise after a Pinkerton agent distributed thousands of the photos on wanted posters across the Southwest.

#### March 2009

#### WHAT'S IN A NAME

Commerce Street in downtown Fort Worth was formerly known as Rusk Street, named for Thomas J. Rusk, a signer of the Texas Declaration of Independence, Secretary of War during the Texas Revolution, veteran of the Battle of San Jacinto, and one of Texas's first two Senators. In the early 1900's the City Council changed the name from Rusk to Commerce because the name Rusk Street had become synonymous with local prostitution, which was centered then in the 1300 and 1400 block of Rusk, and the Council felt the name of a Texas hero was being defamed.

#### February 2010

#### THE FIRE

On April 5, 1909, the largest fire in Fort Worth history destroyed a thirty-two block area on the south side of downtown, including two hundred homes, the Broadway Baptist Church, the Broadway Presbyterian Church, and the Texas and Pacific Roundhouse. Hundreds were left homeless and property loss was over two and one-half million dollars.

#### LOOK TO EXPERTS' REASONING: A RELIABILITY KEY

Enhance your direct and cross examinations seek to avoid relying upon personal biby forcing experts to explain the reasoning that supports their testimony. Experts use inductive reasoning to develop their testimony—similar to how lawyers are trained that are consistent with established proto analyze problems. Inductive reasoning is the "bottom-up" process by which experts gather data through their methods and reason from that data to arrive at their conclusions and opinions. Too often, we focus solely on the expert's methodology, a primary Robinson-Daubert reliability focus, to gauge the reliability of a mental health expert's testimony. Don't stop there. Although reliable opinions can only derive from reliable methods, the reasoning links between the data an expert considers and the expert's opinions are also key elements • with which to gauge the testimony's admissibility. Reasoning from the data to the opinion must make sense and must be . grounded in the "knowledge and experience of the [expert's] discipline. If the "analytical gap" between the data and the opinion is "too great," the testimony should be inadmissible. General Electric Co. v. Joiner, 522 U.S. 136, 146 (1997); Gammill v. Jack Williams Chevrolet, Inc., 972 S.W.2d 713, 726 (Tex. 1997).

Competent mental health expert testimony reflects this reasoning process. For example, an expert, presented with specific referral questions to orient an evaluation, gathers and develops relevant data using reliable, accepted methods. In the process, the expert draws reasonable, professionallybased inferences from the considered data to arrive at the best explanations (opinions) that address the referral questions—picture the analytical, reasoning gap between the data and the opinions. Language from the American Psychological Association's (APA) Guidelines for Child Custody Evaluations in Family Law Proceedings offers an excellent description of the inductive reasoning approach that characterizes any mental health expert testimony: "When making recommendations, psychologists

ases or unsupported beliefs. Recommendations are based upon articulated assumptions, interpretations, and inferences fessional and scientific standards."

In contrast, incompetent expert testimony reflects a compromised reasoning process. A compromised process results in compromised opinions—the analytical gap between the data and the opinions may become "too wide." For example, the following problems in the expert's approach to developing her opinion may infect the process:

- Reliance on insufficient relevant information or data.
- Reasoning not based in the established scientific and professional knowledge of psychology. Daubert v. Merrell Dow Pharmaceuticals, 509 U.S. 579, 592 (1993); APA Ethical Principles of Psychologists and Code of Conduct, Std. 2.04.
- Explicit or unwitting effects of one or more biases that direct the information gathering and reasoning processes.
- Lack of an active approach during the data gathering process that monitors whether biases are influencing the evaluator's interpretation of the data.

Emphasizing both the expert's methodology and the reasoning that links the expert's data to her opinions offers opportunities for sharp, compelling deposition and courtroom examinations of experts. Focus on the "bottom-up" inductive reasoning process. Start with the expert's methods: Are they a generally accepted approach to addressing the problem the expert is addressing? Do the methods generate sufficient data that can inform reliable opinions? Then look to the expert's reasoning from those methods: What explanations did the expert consider to explain the data she considered? What steps did the expert employ to monitor whether biases comprised his interpretations of the data? Why is the expert's opinion the best explanation of the data? Is the expert's opinion supported by sufficient scientific and professional knowledge?

Most mental health experts will use generally accepted methods to gather and develop their data. But focus on the reasoning that the expert uses to tie the data to the opinions to highlight the strengths and weaknesses of the expert's testimony.



## IS THREE TIMES A CHARM? THE IRS ANNOUNCES A THIRD OFFSHORE VOLUNTARY DISCLOSURE INITIATIVE

It was approximately one year ago that I wrote an article, published in the April 2011 issue of Bar Tabs, entitled "Take Two: IRS Voluntary Disclosures and the Offshore Disclosure Initiatives". article discussed the 2011 IRS voluntary disclosure program for offshore bank accounts and other offshore activities that taxpayers were required to disclose to the IRS. In announcing the 2011 initiative, IRS Commissioner Douglas Schulman said that this was the last chance, the IRS would not have another voluntary disclosure program and taxpayers who failed to come forward before the deadline for the 2011 program would face significant problems.

Well, not so fast. On January 9, 2012, the IRS announced it was opening its Offshore Voluntary Disclosure Initiative ("OVDI") for a third time, to allow taxpayers to avoid criminal penalties and reduce exposure to civil monetary penalties by disclosing their offshore bank accounts and other foreign assets to the government. The 2012 OVDI is similar to the previous OVDIs, but has some important changes.

By way of background, the IRS has always had a program that allows a taxpayer who did not report all income or overstated deductions to voluntarily come forward. In 2009, the IRS introduced a special variation of this voluntary disclosure practice, known as the Offshore Voluntary Disclosure Initiative ("OVDI"), which allowed taxpavers who failed to disclose offshore bank accounts and interests in foreign entities, to avoid potential criminal penalties and reduce potential civil penalties. Following the success of the 2009 OVDI, the IRS introduced the 2011 OVDI, which had a deadline for participating of August 2011. In all, the IRS has seen approximately 33,000 voluntary disclosures from the 2009 and 2011 OVDIs. The IRS has collected \$3.4 billion so far from taxpayers who participated in the 2009 OVDI and closed 95% of those cases. In addition, the IRS has already

collected \$1 billion from up front payments required under the 2011 OVDI.

After the close of the 2011 OVDI, many taxpayers continued making voluntary disclosures of offshore bank accounts, trusts and interest in business ventures. The IRS recognized it needed to address this ongoing issue and announced the 2012 OVDI. The terms of the 2012 OVDI are similar to the 2009 and 2011 OVDI with a few small, but important, changes. A taxpayer who participates in the 2012 OVDI must file all original and amended tax returns and include payment for back taxes and interest for up to eight years as well as paying accuracy-related and/or delinquency penalties. In addition, the taxpayer must pay a penalty of 27.5% on the highest aggregate account balance for the last eight years. This compares to the 20% penalty in the 2009 OVDI and the 25% penalty in the 2011 OVDI. For a taxpayer whose aggregate account balance never exceeded \$75,000 during the last eight years, the penalty is reduced to 12.5% of the highest account balance.

The penalty can be further reduced to 5% for taxpayers who can show (1) they did not open or cause the account to be opened; (2) they exercised minimal, infrequent contact with the account, for example, to request account balance, or update accountholder information such as a change in address, contact person, or email address; (3) they did not withdraw more than \$1000 from the account in any year, except for a withdrawal closing the account and transferring the funds to an account in the United States; and (4) they can establish that all applicable U.S. taxes have been paid on the funds deposited in the account.

Although 27.5% of the highest account balance is not an insignificant penalty, it is very small when compared to the potential penalties faced by a taxpayer who does not participate in the program. The penalty for failing to file a Form TD F 90-22.1 Report of Foreign Bank and Financial Accounts ("FBAR") can be as high as

50% of the account balance for each year that an FBAR was not filed. The penalty for failing to file a Form 3520 reporting transactions with foreign trusts or receipt of certain foreign gifts can be up to 35% of the reportable amount each year. The penalty for failure to file the annual foreign trust form, Form 3520-A, is 5% of the trust assets. In addition, undisclosed interests in or transfers to or from foreign partnerships, foreign corporations, and controlled foreign corporations can be significant.

As with the prior programs, a taxpayer who participates in the 2012 OVDI may opt-out of the program if she feels that the penalty is disproportionate or that she has a reasonable cause defense to the application of the penalties. A taxpayer who opts out will be subject to the IRS normal examination procedures and does not have the benefit of the reduced penalties of the program. Careful consideration must be given to whether opting-out of the program is in the taxpayer's best interest, since potentially they will be exposed to some or all of the penalties discussed above.

The most significant change to the 2012 OVDI is that there is not a deadline for participation. However, in announcing the 2012 OVDI, the IRS cautioned that the terms of the program could be changed at any time, including increasing the penalties for some or all taxpayers, redefining the terms of the reduced penalties or redefining the class of taxpayers who are eligible for reduced penalties. In addition, the IRS warned that the program could be terminated at any point, with no advance notice.

Whether a particular taxpayer would benefit from the terms of the 2012 OVDI will depend on careful analysis of certain factors, such as: (i) the penalty amounts that could apply under the 2012 OVDI as compared to the penalties that could otherwise apply under the Internal Revenue

Code and (ii) the number of years that could be open under the applicable statute of limitations as compared to the eight year period for which disclosure must be made, and tax, interest and penalties must be paid, under the 2012 OVDI.

There is no doubt that foreign bank accounts will continue to be a priority for the IRS for the foreseeable future. The Department of Justice is currently investigating 11 banks, Credit Suisse, Bank Julius Bär, Bank Wegelin & Co., Basler Kantonalbank, Zürcher Kantonalbank, HSBC Private Bank (Suisse), NZB, the Swiss daughter bank LLB, and the Israeli banks Leumi, Hapoalim and Mizrahi. The IRS recently announced the indictment of Wegelin & Co. for conspiring to hide more than \$1.2 billion in U.S. taxpayer funds from the IRS.

#### REDISTRICTING IN COLLIN COUNTY - Tom Cowart

I have been half paying attention to all of the redistricting hub-bub in San Antonio and Washington D.C. as the various interest groups fight it out over the district lines that will govern the elections for this year (though, as we know from 2003, not necessarily for the years to come). I have to confess a certain amount of confusion over the issue, though I am very confident that I am not alone in this. But I got to wondering exactly how the fighting could affect our lines here in Collin County.

Just to refresh your memory, the Legislature approved plans to redistrict the state for Congressional, State Senate and State Representative districts in the last legislative session. These districts were challenged in Federal Court in San Antonio (and elsewhere) and the three judge panel considering the challenge issued a map with redrawn districts for use in the elections this year (the "Court-Ordered Interim" Plans). The State appealed the Court's map to the U.S. Supreme Court, which found flaws in the lower Court's approach to the issues and ordered it to redraw its Plans. The Court is expected to issue its new maps sometime this month, which may or may not be in time to have an April primary. Based on what I've seen, though, the Court is expect to modify its earlier map to comply with specific directions from the Supreme Court but is not expected to engage in a complete overhaul of what it has already done. I thought it would be interesting to compare the two most important maps, the Legislature's and the Court's:

Court's Plan overlaid on Legislature's Plan







Court's Plan overlaid on Legislature's Plan


As far as Collin County goes, the lines in these maps are identical - under both plans (again according to the Legislative Council's numbers) 85.8% of Collin's population is in SD 8 and 14.2% is in SD 30. The weight of the Collin County delegation in SD 30 changes though, due to alterations in other parts of the district (Denton County's population contribution goes up by 100,000 and Parker County drops out in the Court's plan). Under the State's plan, Collin makes up 13.71% of SD 30 while under the Court's plan, we make up 13.99% of SD 30. Under both plans, Collin County makes up 84.46% of SD 8 (the other 15.54% is all in Dallas County).



#### Court Ordered Plan


#### Legislature's Enacted Plan





Under both Plans, Collin County has 4 wholly contained State Representative Districts (66, 67, 70, and 89). Each of these wholly-contained districts have a 22% share of the County's population. The County shares one district with Rockwall County, District 33 under the State plan and District 3 under the Court's plan. The numbers for this District are almost identical under both the State and the Court's plans. 12.0% of Collin County's population is in District 33 (the State's Plan), composing 54.49% of the District. District 3 (the Court's Plan) has 11.8% of Collin County's population, which is 53.82% of the District's population. The lines may make a big deal to you if you live in a some areas, like far northeast Melissa, the southern half of Anna, eastern Prosper or eastern Frisco (if you want to see how your neighborhood/area is affected if you are near the line, go to http:// www.tlc.state.tx.us/redist/maps\_online.html and play with the "DistrictViewer"), but it looks like to the County as whole, there is not much difference between the maps.

MY conclusion (everybody else is free to draw their own):

As a County, we are not likely to see much difference no matter what Plan is used at the end. The real fighting is over lines drawn elsewhere. But you should go to the Texas Legislative Council's Redistricting website (http://www.tlc.state.tx.us/redist/maps\_online.html) and play around with the "DistrictViewer" application to draw your own conclusions. •

## Update on UNT Dallas College of Law at Dallas UNT Press Release

#### U.S. District Judge Royal Furgeson to Become Founding Dean of UNT Dallas College of Law

Federal Jurist to Bring "Broad Range of Practical Experience" to new downtown Dallas law school.



Chancellor Lee F. Jackson announced today the appointment of U.S. District Judge Royal Furgeson (*left*) as founding dean of UNT Dallas College of Law, effective April 2013, in anticipation of the law school's opening in August 2014. Dean Designate Furgeson is enthusiastic about assuming his new duties as soon as he can fulfill his obligations to the federal judiciary.

"Our extensive search brought us into contact with many highly regarded legal educators, "Jackson said. "But Judge Furgeson, besides possessing a fine legal mind, brings the kind of broad range of practical experience we were looking for. He's a distinguished judge well known throughout Texas, a respected litigator, and he shares our vision of providing students with an affordable and accessible high-quality legal education."

A Clinton appointee, Judge Furgeson has ridden the federal circuit in Texas for 17 years, first presiding in El Paso, then Midland-Odessa, San Antonio and now Dallas. Prior to taking the bench, he was a shareholder in the prominent El Paso law firm of Kemp, Smith, Duncan & Hammond, where during his 24 years with the firm, he headed the commercial litigation section and remained committed to the pro bono efforts of the firm.

His résumé reflects years of accomplishment and recognition. Among his many honors, he received the Jurist of the Year Award from the Texas Chapter of the American Board of Trial Advocates and the Spirit of Excellence Award from the American Bar Association's Commission on Racial and Ethnic Diversity—both in 2004. Texas Tech University Law School bestowed its 2008 West Texas Legal Legend Award upon the judge, who was born in Lubbock and attended undergraduate school at Tech. He is also a Fellow of the American College of Trial Lawyers and a member of the American Law Institute and the American Board of Trial Advocates.

"Several colleagues have asked me why I would give up a lifetime appointment to take on a start-up law school during these tough economic times, when tuition is rising and demand for lawyers is declining," Judge Furgeson said. "But the prospect of pioneering a new law school that addresses these issues head-on was too challenging and exciting to pass up."

Gov. Rick Perry signed SB 956 on June 19, 2009 to authorize the new law school. The law school will be located in the heart of downtown Dallas, where it can develop partnerships with major law firms, countless solo practitioners and the judicial and legal communities centered in the four courthouses within its two-mile radius. It will be part of the continuing renaissance of downtown, serving as an economic generator for the city, where law students can one day live, apprentice and play (if time allows), after attending classes in the Old Municipal Building, a 1914 Beaux Arts structure of historic significance (it's where Jack Ruby shot Lee Harvey Oswald).

UNT System remains committed to its partnership with the City of Dallas to restore the Old Municipal Building to its former grandeur. The System anticipates this renovation will be complete and ready for occupancy by the law school in 5 to 10 years, depending on the availability of state funds. In the meantime, UNT System will proceed with a \$24 million renovation of 1901 Main Street in downtown Dallas (formerly the Titche/Joske's department store), which will serve as the temporary home of the new law school for at least the first three years of its operations.

UNT Dallas College of Law will be the only public law school in North Texas, and will provide the region with an affordable alternative to private law schools, attracting a high percentage of minority students and easing the debt on all students, as they embark on their legal careers.

Judge Furgeson said he is "eager to get on with the business of running the law school," but first is committed to fulfilling his responsibilities to the federal bench. The judge is currently the president of the Federal Judges Association, a voluntary organization of Article III judges devoted to protecting the role of the judicial branch in our constitutional framework. His personal commitment to this leadership role requires him to remain on the bench for the next 15 months, after which his service to the association ends. Until he formally resigns his judgeship, he will adhere to the Code of Conduct for United States Judges, which will limit his work with the law school.

In the interim, the launch of UNT Dallas College of Law will proceed under the able guidance of UNT System Vice Chancellor Rosemary Haggett. The next three years will see the following developments:

- Appointment of an Associate Dean for Academic Affairs.
- Appointment of an Associate Dean of the Law Library.
- Appointment of a Director of Admissions who will begin accepting student applications in the fall of 2013.
- Construction of the new law library and interim law school offices, starting in 2012.
- Hiring of full-time faculty.
- Matriculation of the first class in August 2014.

Judge Furgeson will remain informed about all the developments of the new law school, and when he leaves the bench in April 2013, he will assume full active leadership as the founding dean and begin the next chapter in his memorable legal career. •
